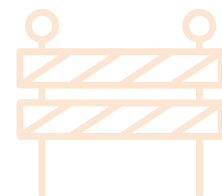


Integrated Policy on Environmental Management, Quality, Occupational Risk Prevention, Road Traffic Safety and R&D&i

• **Perseverance:**


To plan medium and long term objectives, which are the cause and effect of continuous improvement, as we are aware that they are only achievable through effort and the appropriate adaptations to change.
